- Any medications without the Director's prior approval
- After-shave, cologne, mouthwash or hairspray
- Tobacco products for "Roll your owns" or pipe smoking
- Any Non-Christian DVD's, CD's, Tapes or copied disks of any kind, IPOD or any other mass storage device
- Books or magazines except Bible and/or AA/NA books without Program Director's prior approval
- Sleeveless, tank-top, muscle shirts, or any other printed shirts with alcohol/drug, rock-n-roll, or any other design that is not in the spirit of Christianity and recovery
- Clothing with holes and/or tears in possibly inappropriate places
- Short shorts (*all shorts must be fingertip length when standing*)
- Any valuables such as **expensive** jewelry, watches, rings, necklaces, etc.

BRING

- \$850.00 non-refundable Administrative Fee unless prior payment arrangements have been made with the Administrator at 706-764-1460.
- Proof of your current TB test (last 90 days)
- A copy of the Medical Form completed by a medical professional such as a nurse or doctor
- Driver's License or State Picture ID
- Social Security Card
- A 4 weeks supply of approved and current prescriptions and a weekly container for meds.
- Your personal Bible
- Any AA/NA books you have
- 3 Full size spiral notebooks
- Pens, pencils, highlighter
- Coat hangers
- Seasonally appropriate attire such as jeans, khaki pants, shorts. Shirts must have some type of sleeve (T-shirts ok). Nothing dressy required. At least one collared shirt for church and job hunting. Work Clothes.
- Wash cloths, towels, shower shoes
- Bed linens and blankets for twin size bed
- Waterproof Mattress Cover
- Pillow and pillow cases
- Laundry bag
- Laundry detergent
- Reading glasses if needed
- Tooth paste and brush, deodorant, shaving needs, soap, shampoo, plastic box to keep toiletries in

OPTIONAL: Softball glove, fishing pole with valid State of Georgia Fishing License, sleeping bag and bed roll for camping
